### INTRODUCTION

The KJ McPherson Education & Research Foundation (KJM Foundation) was established to provide research and professional development opportunities for uniformed Queensland Ambulance Service (QAS) personnel above and beyond those opportunities provided within the budget of Queensland Ambulance.

#### WHAT DOES THE KJM FOUNDATION DO?

The KJM Foundation raises money by way of payroll deductions, gifts (donations and bequests) and sponsorships. Donations help equip QAS Paramedics with educational and research skills over and above the already high standards provided by conventional funding. The KJM Foundation also receives in kind support of a part-time administrative assistant from QAS to administer these functions.

Each year the KJM Foundation holds a Patron's Day Professional Development Symposium and Grants Presentation. The main purpose of funds raised by the KJM Foundation is to offer personal and professional development opportunities for QAS uniformed personnel researching opportunities to contribute to enhance QAS clinical practice and operations, leading improvements to paramedic practice and extending the contribution of paramedics to out-of-hospital care. A background on the evolution of the KJM Foundation since 1988 follows.

# ESTABLISHING THE TRUST – WHICH LATER BECAME A FOUNDATION

Since 1892, Queensland Ambulance officers have earned the respect of the Queensland community through their care and dedication to patients. Sadly for some officers it has cost their life, but in the case of Kenneth James (Jim) McPherson, the tragic loss of his life in 1987 whilst on duty gave rise to the establishment of the Kenneth James McPherson Memorial Trust, so that his memory would live on through this trust to facilitate opportunities for the development of QAS uniformed personnel into the future.

### TRAGEDY

At 0317 hours on Sunday 21 June 1987, Jim McPherson lost his life aged 27 years in an aerial ambulance crash soon after takeoff from the Bundaberg Airport. Jim was the Aerial Ambulance Attendant on that flight escorting a seriously injured female patient to Brisbane along with the pilot and nurse. Jim left a legacy of commitment to ambulance education to continue learning and developing new skills.

#### **KENNETH JAMES (JIM) MCPHERSON**

Jim McPherson had lived ambulance services throughout his short life. The son of John and Jean McPherson, young Jim was born on 16 January 1960 in Brisbane into a family of patient carers, with his father an ambulance officer with Queensland Ambulance Transport Brigade (QATB) and his mother a nurse. His early exposure to ambulance was very broad, with his father serving in many places, rural, remote and urban, including Brisbane, Theodore, Thursday Island, Kingaroy and Rockhampton. Jim served as an Honorary Ambulance Officer in Kingaroy from the age of 17, was appointed to the permanent staff at age 19 and was later appointed to the Bundaberg Centre where his duties included that of Aerial Ambulance Attendant.

It was characteristic of Jim McPherson to contribute above and beyond the call of duty. He was highly competent with video equipment, a skilled First Aid Instructor and heavily involved in QATB fundraising activities at Kingaroy and Bundaberg. Jim was an outstanding professional with a commitment to developing his skills in order to provide the best possible care to patients.

Jim's father, John McPherson (deceased), served as a QATB Superintendent across the State and retired as Deputy Commissioner Operations QAS. John and Jean (also deceased) both served on the trust and foundation committees for many years.

Jim was awarded the Queensland Ambulance Distinguished Service Medal on 23 June 1992.

#### ORIGINS OF THE KJM FOUNDATION

Jim McPherson was highly regarded by his fellow officers, and his loss touched many of his colleagues. Jim had demonstrated a strong interest in, and commitment to, the thorough training of ambulance officers. This commitment had been evident to Mick Davis who was Training Officer at Rockhampton in the early 1980s, serving under Superintendent John McPherson.

In late July 1987, Mick Davis proposed to John McPherson that Jim's memory and his commitment should live on in the form of a trust fund that would help future ambulance officers realise opportunities for research and development. With John's approval and support, Mick wrote up his proposal and submitted it to the Queensland Ambulance Services Board (QASB) on 14 August 1987 under their joint signatures. The proposal was also presented to the delegates at the State Conference of QATB Committees in August 1987 by Dr W Christie, Chairman of the Rockhampton QATB Committee.

The proposal for the trust was considered and accepted, in its presented terms, without alteration, by the QASB at its meeting of 28 August 1987. The board also approved that the "Rockhampton QATB committee liaise with relevant government departments, including the Australian Taxation Office, in order to establish the trust."

The QASB at the time also accepted the responsibility to act as trustee and administrator for the trust once established. The support of the Chair of the QASB, Mr Gerald Moore and the Manager QASB, Mr Ian Boddice was important in the board's acceptance of this proposal. The board's solicitors were consulted regarding appropriate procedures for the establishment of the trust.

On 21 June 1988, the Australian Tax Office approved trust fund donations as "allowable deductions" under Taxation exemptions granted to the QATB. The trust was established by authorised signatures on 4 August 1988 as the Kenneth James McPherson Memorial Trust.

The first KJM Foundation logo and brand was created in 2002 and used until August 2007. It was initially used on KJM Foundation letterheads, compliment slips and business cards, with information posted on the QAS intranet and later, on the KJM Foundation web page.

In conjunction with the above, a simple badge-style version was also created in both colour and monochrome presentation. In the course of everyday usage, this version emerged as the common and most recognisable format of the logo.



With a change of name for the KJM Foundation in 2007, came the change of title wrapped around the central component of the KJM logo along with a slight variation in the colour tones.

For the 30 year celebration of the KJM Foundation in 2018, an acknowledgement and special promotional logo was created for the KJM Foundation by the QAS Design Studio. Throughout 2018 this logo appeared in conjunction with the standard logo on web pages, documents, promotional banners and on promotional merchandise.

Following the 30 year celebrations, the KJM Foundation board considered it appropriate to mark the occasion going forward with the addition of a simple statement to the logo, 'since 1988'.

Following a lengthy consideration of the underpinning purpose of the KJM Foundation, its reason for existence and its core values, it was decided to review the logo with the aim of retaining the well-recognised logo image with simplification of the accompanying text and opting for a two colour toning.

#### FINANCING THE TRUST

The day of 4 August 1988 marked the approval by the Honourable Minister for Health for the QASB to act as trustee for the Kenneth James McPherson Memorial Trust.

In order to encourage donations to the newly formed trust, the Rockhampton QATB committee produced an information and promotional document for widespread distribution throughout Queensland.

On 19 September 1988, the board established a special account for the trust at the Commonwealth Bank.

A grant of \$10,000 from the Queensland Department of Health, donations from QASB, from QATB committees, individual committee persons, ambulance officers, businesses and members of the public gave the trust fund proposal its financial reality. The first bequest to be deposited in the trust was \$1,000 from the estate of the late Isabel Bertha Castner. Committee donations were the subject of much doubt in the early months because of the tight legal prescriptions for QATB committee disbursements in the application of their funds. Ministerial approval for committee donations helped resolve these difficulties. The Federated Miscellaneous Workers Union (FMWU), which represented ambulance officers in Queensland also contributed to the trust. The union was also invited to appoint a member to participate as a representative of Queensland Ambulance personnel in appreciation for this support.

By 14 June 1989, the trust fund had grown to \$15,898 and on to \$21,500 by 29 September 1989 and is steadily growing.

#### CONTINUITY AND SUPPORT

From time to time promotion of the trust and its ideals has engendered support from a number of sources to maintain the fund. A donation from Suncorp for \$7,000 was received in the early 1990s and a donation of \$1,300 for "education and research" was received from the Windsor Rotary Club in 1997.

The conditions of these donations prompted a review of the trust deed in 1998. A new ruling from the Australian Tax Office (ATO) brought the trust deed into question relevant to the trust's ongoing exemption from income tax. The scope and objects of the trust deed were inclusive of provisions for distribution of research grants to persons other than ambulance officers, who undertook "approved" pre-hospital care research. The trust deed was revised to comply with the new ATO provisions.

Donations by way of fortnightly payroll deductions from staff were encouraged. QATB Committees were canvassed for support and following the establishment of the QAS in 1991, the transition of the QATB committees into Local Ambulance Committees (LACs) has resulted in that support continuing. This LAC support has included a donation of \$5000. Over the years there have also been bequests from time to time.

#### FORMALISING THE KJM FOUNDATION

On 18 August 1998 a meeting of the trustee's agents recommended that the QAS investigate:

- < the establishment of a research and education foundation, to be known as the Kenneth James McPherson Foundation
- $\ll$  whether the existing trust funds could be transferred to the new foundation
- whether the trust should bear the costs of this change.

The QAS sought advice from Crown Law regarding these proposals. Crown Law responded on 6 January 1999 with a proposed deed of variation, advising that *"the additional purposes are not in any way contrary to the provisions of clause 7 of the original trust deed"*. It was then necessary to refer this proposed deed of variation to the Australian Taxation Office for a ruling on taxation exemptions.

In consultation with, and under the signatures of the McPherson family, a new deed was signed on 29 May 2000 establishing the Kenneth James McPherson Foundation.

In 2016, the KJM Foundation relinquished its deductible-gifts grants status due to changes in the Australian taxation laws and remodelling allowed the trustee to change from the State of Queensland to the board administering the KJM Foundation.

#### FOUNDATION PATRON

With the establishment of the KIM Foundation. Emeritus Professor, Major-General John Pearn, AO, RFD accepted the role of patron. Professor Pearn is a prominent Australian who has assisted and supported ambulance clinical activity for many years. He has been Oueenslander of the Year and a nominee for Senior Australian of the Year. He is a leader in the field of Child Health with extensive research publications, and a former Surgeon-General in the Australian Defence Force with extensive experience in academic systems, clinical practice, military and civilian health systems and third world disaster response. Professor Pearn was awarded the prestigious, international and rarely-awarded Bailiff Grand Cross for St John Ambulance in 2014. In 2016, he was personally presented the King Edward VII Cup for outstanding international service to lifesaving by Her Majesty the Queen.

#### AWARDS AND GRANTS

On 30 October 1989, the QASB (Trustee) resolved that from 1990 onwards, an annual grant or award would be continued from the accumulated interest of the trust.

In order to commence the awards from the trust, the McPherson family established the Jim McPherson Memorial Shield (can be viewed in the foyer at the Kedron Park, Emergency Services Complex), to be awarded for excellence in the Trauma Section for the Institute of Ambulance Officers (Australia), Queensland Division, State Scenario Skills Competitions. An annual trust award of \$250 for medical books was made with the shield to the two members of the winning team for the Trauma Event. The shield was then displayed in their station or regional office.

Ambulance Officers Stewart Carroll and David Lewis were the first recipients of the Award for Excellence in Trauma.

With the establishment of the QAS in July 1991 and the dissolution of the QASB, the QAS became trustee so that the administration of the trust continued. The trust fund had grown more slowly since 1989 and recorded a balance of \$25,274.57 on 30 October 1999.

The trust supported the Institute of Ambulance Officers (Australia), Queensland Division, International Pre-Hospital Care Conference held on the Gold Coast in October 1992 by funding an ambulance officer *"making an outstanding contribution to the development of the new QAS"*.

On 13 October 1992, District Operations Coordinator Bruce Chalmers of Dalby was advised he had won the above award from the trust. A further award was made in 1992 to Student Ambulance Officer Dennis Jess who proposed a research study to review the use of chemical disinfectants by QAS. Neil Kirby and Mick Davis were also granted awards in 1992 for the development and implementation of the landmark qualification for Ambulance Officers, the Associate Diploma of Applied Science (Ambulance). Awards for the Trauma Section Winners of the Institute of Ambulance Officers Australia (IAO) State Competitions continued until 1999 when the competitions were replaced with clinical excellence grants.

Other recipients since 1992 have included Cheryl Stace (QAS Dux, Assoc. Dip 1992–93), Communications Centre Supervisor Barry Plotzki (CAD), Training Coordinator Robert Stone (Distance Education), Graham Reid (Assoc. Dip.) and Gavin Leader (Paramedic). John Murray and Brett Rogers won the QAS Personal Development Award in 2003 for research on "The Early Identification of Patients for Thrombolysis by Intensive Care Paramedics". Gavin Leader won the QAS Personal Development Award in 2004 for "Remote Paramedic Practice - Ghana experience". Anthony Smith won the QAS Research & Development Award in 2005 for "Evaluation of QAS Administered Dosages of Salbutamol for Paediatrics in the pre-hospital environment".

The initial Patron's Research Grant in 2006 was won by Lachlan Parker for "A descriptive analysis of Flight Intensive Care Paramedic Operations in Brisbane over a 6-month period". Other Patron's Research Grant recipients include: Brad Setch in 2010 for "Determining whether vehicle relocation allows for faster extrication or poses any clinical risk to patients of the Road Traffic Crash (RTC) patient". Mark Disney in 2012 for "Graduate Certificate in Public Health".

In 2017 Lisa Davenport published her grant project of a study of burn trauma and infection and pre-hospital treatment to reduce coagulation, inflammation and metabolic stress.

Over the years further professional and personal development grants were introduced and sponsors sought. The KJM Foundation continues to provide a range of grants for significant professional development opportunities for the benefit of QAS uniformed personnel, their patients and communities. The grants offer research opportunities to enhance QAS clinical practice and operations, leading to improvements in paramedic practice and extending the contribution of paramedics to out-of-hospital care.

## WHAT RECIPIENTS DO WITH THEIR GRANTS AND AREAS OF RESEARCH AND EDUCATION

Recipients typically apply the grants in of the following ways:

- Clinical operational research
- Clinical operational studies
- C attending educational events
- c exploring improved operational procedures
- improving clinical protocols.

Recipients typically apply their grants to the following areas of research and education:

- clinical priorities including acute respiratory events, trauma management, clinical decision making and area medical management
- $\ll$  educational issues such as delivery methods and professional development strategies
- c operational systems issues including appropriate segmentation of workload, impact of health information/advice services on QAS activity levels, Advanced Medical Priority Dispatch System and crew deployment
- < mental health issues including improvements in the area of staff support and personal trauma.

In 2013 the KJM Foundation had a pool of unused grant money and with approval of the foundation auditor established a Local Ambulance Service Network (LASN) Special Development Grant specifically for the application of these unused grant monies.

This grant is considered on application each year subject to the available funds. The examples of the range of successful projects include conference attendance, special clinical practice courses, short course of study, short professional development activities and clinical or operational projects of specific benefit to particular LASNs.



# THE IMPACT OF THE KJM FOUNDATION ON QAS

Since its origin in 1988 the KJM Foundation has contributed to the professional development of QAS uniformed personnel through a range of grants. It has encouraged excellence of personnel and directly influenced QAS clinical operational practice through grants to encourage and facilitate research and development by ambulance practitioners.

A very practical example of the direct impact of grantsupported research was the introduction of Thrombolytic therapy into QAS Coronary Care Clinical Practice, as a result of the findings of a study partially funded by the KJM Foundation. An example of foundation funded professional development was the challenges successfully overcome by Gavin Leader through his experience with international disaster response teams as a paramedic practitioner in Rwanda.
